GOOD SHEPHERD SCHOLARSHIP

The Good Shepherd Scholarship enables families of all income levels to receive a Catholic education. If you desire a quality education in the Catholic tradition for your child or loved one, we invite you to apply for The Good Shepherd Scholarship. The Good Shepherd Scholarships are based on financial need, which is verified through a third-party application. We utilize FACTS Management for scholarship applications, which helps us ensure fair and equal treatment, and also helps to keep financial information secure. ST. PETER CATHOLIC SCHOOL DISCIPLESHIP SCHOLARSHIP

To qualify for this scholarship, you must be a registered member of St. Peter Catholic Church. You must give of your time, talent and treasure to St. Peter Parish which will be verified in the database. There are no income level requirements, so you do NOT need to fill out FACTS to qualify for this scholarship. Households that are awarded the Discipleship Scholarship will receive up \$1,000 per St. Peter student in grades K-8.

FAMILY TUITION CAP SCHOLARSHIP

If you have more than three students in grades Kindergarten through 8th grade who attend St. Peter Catholic School. The scholarship will cover the cost of tuition for the 4th and each subsequent student registered at St. Peter School. Families will be responsible for all other fees.
